

This newsletter will be mailed quarterly and is intended to keep you informed on RAWS's current events and happenings.

DROUGHT INFORMATION

As you may already be aware, most of the South Texas area is in the beginning stages of a severe drought. Extended periods of no rain and demand for water from the lake means lake levels deplete quickly.

RAWS has in place an official drought contingency plan (DCP), located on our website, which will be implemented accordingly. RAWs encourages you to locate and make yourself familiar with the various stages of the plan so we can all do our part to conserve water during this drought!



The DCP was created so that RAWs can cut back demand when supplies are low, so the residents have enough water to make it through a drought. The DCP clearly explains the triggers initiated by a drought and the steps to be taken during each stage of a drought. The DCP only takes effect when there are drought conditions.

WATER TIP OF THE MONTH!

RAWS is currently at 80% system capacity.

To satisfy growth and maintain regulatory compliance, RAWS must begin the planning stages of erecting a new elevated storage tank to increase the capacity of the system at 75% system capacity. In which case, RAWS has officially begun the planning stages of erecting the new elevated storage tank.

Once RAWS reaches 90% capacity, RAWS must begin the construction phase of increasing storage capacity.
