DROUGHT CONDITIONS

The current lake levels are at 17.7% and we are currently in Stage 3 of Drought Restrictions. Restrictions for Stage 3 are as follows:

- 1 - Irrigation of landscaped areas is prohibited at all times (unless use of private water well).
- 2 - Use of water to wash any motor vehicle, motorbike, boat, trailer, or other vehicle not occurring on the premises of a commercial car wash station and not in the immediate interest of public health, safety, and welfare is prohibited.
- 3 - The filling or refilling to swimming pools, wading pools, jacuzzi-type pools, and water parks (unless non-city, alternative source) is prohibited

*****There is an exception to "topping off" your swimming pool to maintain water levels and/or integrity of pump systems.*****

DROUGHT CONDITIONS CONT.

- 4 - The use of water to maintain the integrity of a building foundation is still permitted on the designated Stage 2 watering day and shall be done by hand or drip irrigation method.
- 5 - All fountains shall only operate to circulate water to maintain equipment.

PROTECT YOUR PETS FROM THE SUMMER HEAT!



- Prepare for power outages.


